Dear Tribal Leader:

The Centers for Disease Control and Prevention/Agency for Toxic Substances and Disease Registry (CDC/ATSDR) Tribal Advisory Committee (TAC) is currently recruiting to fill delegate vacancies in the Nashville area (Delegate and Alternate), Portland Area (Delegate and Alternate), and (7) additional alternate positions in the remaining areas listed below. The alternate positions are not required to be affiliated with the same tribe as the primary delegate. For a thorough understanding of the primary and alternate roles, please see the [TAC Charter](#).

Nominated area delegates must be qualified to represent the views of tribes within the area, be an elected tribal leader, and work in their official capacity. Please share the vacancy announcement with your tribal leader partners located in the Albuquerque, Billings, California, Nashville, and Portland areas, and encourage them to nominate elected tribal officials to represent their area on the TAC. Please share this message broadly with tribal leaders to encourage them to nominate candidates for the (4) National At-Large Tribal Member alternate vacancies.
